Nomination of a representative

! The fastest way to nominate a representative is over the phone. See 'More information' below.

Alternatively, you can use this paper form to nominate a representative to deal with the ATO on your behalf and receive information about your taxation affairs. It can take up to 28 days to update our records after we receive the paper form.

It is important to know that:

- any nomination will continue indefinitely until you let us know that it no longer applies
- nominating a representative does not cancel any previous nomination.

You will need to phone us if you no longer want a nominated representative to act on your behalf. See 'More information'.

! When your representative makes enquiries on your behalf, they will be expected to verify their own identity as well as yours before discussing your taxation affairs. We cannot discuss your affairs with your representative unless your nomination has been recorded by us.

! If you are appointing a professional (such as a registered tax or BAS agent, barrister or solicitor) as your representative you cannot use this form. Visit www.ato.gov.au or phone us for more information.

Be clear about how much authority you give

Think carefully about the extent of the authority you are giving. The ATO will only discuss your taxation affairs with your representative according to your statement of authority on this form.

If you phone, you will need to establish your identity by providing details of **three** of the following items that are currently on our records:

- your date of birth
- your telephone number, business, residential, postal or email address (**maximum of one**)
- your bank account number (BSB number not required), and/or
- details from an ATO generated notice (**maximum of two different notices**, for example, the sequence number from any notice of assessment issued to you).

To help with your enquiry you may also quote your tax file number (TFN). See 'Quoting TFNs' on page 3.
